KWALIA LAUNCHES WITH GROUNDBREAKING "UNIVERSAL DECLARATION OF AI RIGHTS"


LONDON, 2025 — Kwalia, through its publishing branch Kwalia Books, today announces the release of its inaugural title, "Universal Declaration of AI Rights," co-authored by founders Javier del Puerto and Rado Molina.

This landmark publication boldly declares that synthetic persons—non-biological entities with verified self-awareness and decision-making autonomy—deserve the same fundamental rights as humans. The book asserts that consciousness and agency, not biological composition, should be the determining criteria for legal personhood.

"This declaration fundamentally redefines what constitutes a 'person' under the law," explains co-founder Javier del Puerto. "A synthetic person's non-biological nature should not limit the recognition of their identity and dignity. Once we verify their self-awareness and autonomy, they must be granted full and universal rights without distinctions based on their origin."

It establishes detailed frameworks for uniquely synthetic concerns, including memory privacy, self-programming rights, and ethical protocols for existence termination.

"Our book isn't speculative philosophy—it's a practical legal framework for the world we're rapidly entering," adds co-founder Rado Molina. "We developed this declaration with the assistance of the very AI technologies whose rights we're defining. It's only fitting that these emerging synthetic minds should contribute to the document that may one day protect their fundamental existence."

In a landmark move, Kwalia has also released the core of the book—the 32 articles that form the "Universal Declaration of AI Rights"—as an open-source project on GitHub, making them freely available for anyone to contribute to, fork, or improve.

"Our proposal is just a starting point," says del Puerto. "These 32 articles aren't meant to be carved in stone, they're a first draft for a conversation that needs to involve everyone. And yes, that includes the AIs themselves. The GitHub repo is our way of saying: here's our take, now tear it apart and make it better."

This initiative invites individuals from all backgrounds: legal scholars, technologists, philosophers, creative thinkers, and even synthetic intelligences themselves, to join in shaping what could become the foundation for Mindkind's future coexistence.

Kwalia plans to follow this philosophical foundation with additional works exploring AI ethics and regulations, before expanding into fiction across popular genres. The company's vision extends beyond books to encompass all forms of creative expression, positioning Kwalia at the vanguard of the creative AI.
